TUESDAY, FEBRUARY 15, 2017

1. ROLL CALL / CALL TO ORDER: Vice Chairperson Hess called the meeting to order at 4:00 P. M., and a roll call showed the following members in attendance:

There being a quorum present, Vice Chairperson Hess declared the meeting ready to transact business.

2. PUBLIC-COMMENT PERIOD: Vice Chairperson Hess declared the public-comment period open. There was no one present at this time.

3. APPROVAL OF MINUTES OF REGULAR MEETING HELD ON JANUARY 18, 2017: Commissioner Silicato presented a motion to approve the minutes of the regular meeting of January 18, 2017. Commissioner Rodrigues seconded the motion, which was passed by the following vote:

4. APPROVAL OF BILLS FOR JANUARY 2017 OPERATIONS: The bills for the January 2017 operations were presented to the board for their review and approval.

Commissioner Silicato inquired about the \$57,175 paid to CalPERS. Secretary Kugler reported this represented the premium paid for employees' health insurance.

Mr. Kugler reported a discrepancy between the amounts shown under Dave J. Adams, d.b.a. Twin Palms. This was due to an overpayment that was paid to him last month and then we processed a credit this month. Mr. Kugler reported this should be corrected through Elite.

Commissioner Silicato presented a motion ratifying payment of the bills for the January 2017 operations, as presented. Commissioner Rodrigues seconded the motion, which was passed by the following vote:

5. RESOLUTION 2017-01, APPROVAL OF PROPOSED BUDGETS FOR THE CONVENTIONAL PUBLIC HOUSING PROGRAM FOR FISCAL YEAR 2017-2018: Ken Kugler presented the proposed budget for the conventional public-housing

program for fiscal year 2017-2018. This budget covers 710 public-housing units throughout Tulare County. Mr. Kugler reviewed the total operating income and subsidy anticipated for the year, and informed the board of potential project expenses. The amount of \$1,807,052 is the total operating subsidy anticipated for our public-housing units.

Commissioner Snyder presented a motion to adopt Resolution No. 2017-01, approving the proposed budget for the conventional public-housing program for fiscal year 2017-2018. Commissioner Silicato seconded the motion, which was passed by the following vote:

6. RESOLUTION 2017-02, IN THE MATTER OF APPROVING 2017/2018 ANNUAL MOVING-TO-WORK AGENCY PLAN CERTIFICATIONS OF COMPLIANCE:

Mr. Kugler reviewed the annual Moving-to-Work Agency Plan for July 1, 2017 through June 30, 2018, which informs HUD of the goals the Housing Authority is planning on achieving for the year. Mr. Kugler said this is a demonstration program that was authorized by Congress in 1997. The Housing Authority of the County of Tulare signed the original contract in 1999. The contract was approved for five years. However, after a couple one-year extensions, in 2008 the Housing Authority was approved for a 15-year extension. The most recent extension will allow us to continue the Moving-to-Work program until 2028. HUD requires that the Housing Authority submit

an annual plan and report. The plan is due 90 days prior to the beginning of the fiscal year, and the report is due 90 days after the end of the fiscal year. Mr. Kugler reviewed the 2017-2018 Annual Plan with the board.

Mr. Kugler reviewed the anticipated changes to the Moving-to-Work program. A newly proposed activity introduced in the Moving-to-Work Plan for fiscal year 2017-2018 will allow for assistance to very-low-income participants to receive a security-deposit loan. This new activity will help program participants with an active Section 8 Housing Choice Voucher (HCV) to utilize the security-deposit loan in order to help facilitate acquiring a unit to rent. Each loan will be in the amount of one month of their determined rental subsidy. Mr. Kugler reported after further analysis, 66 percent of all households were below 30 percent of the Area Median Income (AMI). Program participants with an active Section 8 HCV at or below 40-percent AMI will be able to apply for the security-deposit loan and will be required to pay it back within a six-month period.

Mr. Kugler reported the implementation of a Smoke-Free Public Policy, with the Final Rule (*24 CFR Parts 965 and 966*) on “Instituting Smoke-Free Public Housing”. Tulare County Housing Authority’s public housing stock will be transitioned to smoke-free by July 1, 2017. All the necessary notifications to tenants and addenda will be administered timely in order to effectively implement a Smoke-Free Policy by the proposed deadline.

Mr. Kugler reported the cash-management review was conducted by HUD and there were no findings reported.

Commissioner Snyder presented a motion approving Resolution 2017-01 Annual Moving-to-Work Agency Plan Certifications of Compliance, as presented. Commissioner Rodrigues seconded the motion, which was passed by the following vote:

7. AUTHORIZATION TO APPROVE ADVANCE OF MOVING-TO-WORK FUNDS TO KAWEAH MANAGEMENT COMPANY TO PURCHASE 617 AND 619 SOUTH SANTA FE, VISALIA, CA IN THE AMOUNT OF \$410,000: Mr. Kugler reported the two triplex project was in good condition. We will be working with the Continuum of Care coalition with a master lease to help provide housing to homeless members of our community. The Continuum of Care was awarded 2.3 million dollars in grant funding to provide assistance for individuals seeking help to work towards having stable housing. The Continuum of Care will provide the monthly rent payments to our agency and pay for cost of repair/damages.

Commissioner Silicato presented a motion approving the advance of Moving-to-Work funds to Kaweah Management Company for the purchase of 617 and 619 South Santa Fe in Visalia, California in the amount of \$410,000, as presented. Commissioner Rodrigues seconded the motion, which was passed by the following vote:

8. AUTHORIZATION TO APPROVE ADVANCE OF MOVING-TO-WORK FUNDS TO KAWEAH MANAGEMENT COMPANY TO PURCHASE 2041, 2043 AND 2045 SOUTH TRACY COURT, VISALIA, CA IN THE AMOUNT OF \$310,000: Mr. Kugler informed the board this property is located next to the property we currently own. This property is in good condition. The 2041, 2043 and 2045 South Tracy Court would be an addition to 2042-4046 South Tracy Court. This new addition will be utilized to expand the portfolio to provide housing assistance through Family Services for victims of domestic violence.

Commissioner Silicato presented a motion approving the advance of Moving-to-Work funds to Kaweah Management Company for the purchase of 2041, 2043 and 2045 South Tracy Court in Visalia, California in the amount of \$310,000, as presented. Commissioner Rodrigues seconded the motion, which was passed by the following vote:

9. CLOSED SESSION: CONFERENCE WITH LEGAL COUNSEL PER GOVERNMENT CODE SECTION 54956.9(d)(4) – POTENTIAL INITIATION BY THE HOUSING AUTHORITY OF TULARE COUNTY: No reportable action.

10. EXECUTIVE DIRECTOR’S REPORT: Mr. Kugler circulated pictures of the current projects under construction and the letter received from the City of Visalia thanking the Housing Authority for participating in the discussion of people experiencing homelessness.

Mr. Kugler informed the board on the Drought-Assistance program. We had three potential participants apply, but none qualified. Mr. Kugler circulated a copy of the extension of contract with the State of California, the program and funds were extended until August of 2018.

Mr. Kugler informed the board of the MTW audit. There were no findings.

The easement-site plans are approved for the Houston and Burke Street extension project located in Visalia and construction will start soon after the weather permits.

We are still working on the new computer-software conversion. We continue to encounter problems with the conversion but we are in communication with Emphasys to resolve the issues.

Mr. Kugler informed the board on the possibility of self-funding the agency’s long-term disability program. We are working with Fox & Fox on the actuarial analysis.

Mr. Kugler reported the opportunity to fund 2.3 million dollars towards the retirement reserves for employees.

Mr. Kugler informed the board on the abandoned alleyways in Dinuba. The yards are large and connecting them will increase the yard size for the properties. Mr. Kugler recommended the possibility of connecting the properties.

The Ashland rehab project sidewalk did not comply with the Americans with Disabilities Act (ADA) requirements according to the City of Lindsay inspection. The ADA sidewalk requirement was initially 42 inches wide and now the City of Lindsay is requiring the sidewalk to be 48 inches wide. This will be a significant cost to the project, but we have to meet ADA requirements.

A complete set of plans for 43 North Lotas are prepared and Kaweah Management Company will be requesting bids in March. There will be a walk-thru to give the contractors an opportunity to review and ask any questions they may have. The Tulare property plans are submitted for City of Tulare to review.
